Dear Ms. Selva,

I do not know who else to give this information. I need to pass on this information because I believe it would be wrong for me not to. Perhaps it means nothing, but I rather be a nuisance than withhold possible important information. I have you as a contact and we corresponded last fall.

We have confirmed that the DATE on our DNA test was falsified. I had custody of the child on the date the test was supposedly taken (10-04-2007) because I was fostering in Antigua. She was not giving a sample on that date. The Chain of Custody was not followed. We doubt the legitimacy of the test now. Below my email is a response from our facilitator, Karla Ordonez, about what she did with this DNA.

I am assuming this negates the Pre-Approval. What happens now? We cannot continue this adoption in good faith due to this and other problems we have had. There is too much doubt. We don't want to improperly bring in a child to the US, or worse, tear apart another family to create ours.

My past experience with adoption fraud has made me very skeptical, and I question everything. Since the beginning of this adoption (July 2007), our agency Adoption Blessings Worldwide was profiled on Dateline in January for kidnapping. Also, I was told I could not foster anymore (once we got to Family Court in January having custody of
I witnessed my facilitator trying to get a stranger in Family Court to stand in as the Foster Mother (for court). I refused to follow through with this lie and that first court date was cancelled. I told my adoption agency, facilitator, and ASG that I questioned the ethics of this adoption over and over.  I was told to basically look the other way or my concerns were ignored or dismissed. I was told the birthmother was missing. I was told many lies, and many strange things.
Adoption Supervisors Guatemala (Marco Tulio) managed to convince Karla Ordonez to allow my live-in nanny, to be the legal foster mother. I didn't want one of Karla's foster moms to have because she was sick when we first got her and horribly cared for.
I left Guatemala on February 13 for many reasons, mostly that I couldn't foster legally and I trusted to properly care for
Currently, (whom we called ) is living at home, outside Antigua. We pay 600 a month (plus) to care for is the legal foster mother now and has papers. If you need the address, please let me know.
We question the age of as she appears older than is what is on her BC (she is very large and has most if not all of her teeth at exactly one year).  Her BC is Mixco issued.

I was told that Ricardo Ordonez, our attorney, is under investigation by the PNC and is likely to face jail time. Karla Ordonez told me that their office had been raided by the PNC and they moved their files "to another location".

When I went to their "office" once, it appears it was just a front. There were no working phones, no persons there. This is the same building as the doctor who is on our DNA test. It is right across the street from the US Embassy, in the Aristos Bldg.
